HEERF II REPORTING

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), was signed into law on December 27, 2020. CRRSAA provides for education stabilization through emergency funding to institutions of higher education through a second round of Higher Education Emergency Relief Funds (HEERF II). Institutions accepting CRRSAA funding must commit to providing a portion of the funds in the form of financial aid grants to students, which can be used for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus.

REPORTING TIMELINE

Reports are due quarterly and must be posted on the institution's primary website no later than 10 calendar days after the calendar quarter.

- January 10, April 10, July 10, October 10
- HEERF II Exception: Quarterly reporting for HEERF II for the first quarter of 2021 has been extended to the end of the second calendar quarter, June 30, 2021.

Once funds are fully spent, the institution may indicate that this is the institution's final quarterly posting and that it covers all remaining HEERF fund expenditures for that specific HEERF Student Portion of funding. After posting, no more quarterly public reporting of Student Portion funds is required.

REQUIRED REPORTING INFORMATION

5.The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive:

In an attempt to meet Congress's intent to deliver emergency student aid relief as expeditiously as possible, while prioritizing populations with exceptional financial need, Luckes provided block awards to three categories of students:

- Students with a Pell eligible EFC that are enrolled: EFC 1-2500, EFC 2501-5000, and EFC over 5000
- Students with no FAFSA on file or non-Pell eligible EFC that are enrolled were compared to students that has an EFC, it is based off income documentation provided to Financial Aid Administrator.

Enrollment and financial aid status were determined as of June 29, 2021.

Student eligibility criteria was determined by the recommended guidelines published by the U.S. Department of Education. The Department has since updated student eligibility criteria, applicable to all unspent HEERF funds.

Student Emergency Aid Application – 2nd round Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA 2021)

The U.S. Department of Education has provided guidance to universities for the distribution of a second round of emergency grants to college students. These funds must provide students with financial aid grants, which may be used for any component of the student's cost of attendance, or for emergency costs that arise due to coronavirus. These costs include tuition, food, housing, course materials, technology, health care or childcare.

Students who are experiencing an unanticipated and/or temporary hardship resulting from an emergency and/or crisis related to COVID-19 may apply for an emergency financial assistance grant. The amount of each emergency financial assistance grant awarded will be based on 2020/2021 FAFSA Application. 0 EFC students get amount, EFCs of 1-2500 get Y amount, EFCs of 2501-5000 get Z amount and students over 5000 get the lowest amount.

Applications will be available June 23, 2021 and will be reviewed in the order they are submitted. Completed application must be returned to the Financial Aid Administrator Office to Mrs. Jennifer Dent.

2 The Department's guidance for emergency financial aid grants under section 18004(a)(1) of the CARES Act did not advise institutions to use such grants to satisfy a student's outstanding account balance. However, upon further consideration, the Department believes that allowing students to consent to the application of a CRRSAA financial aid grant to their student accounts would facilitate such a use of funds, if desired by the student, while retaining the student's discretion to determine what costs should be covered with his or her financial aid grant funds

Disbursing of Funds

Grants will be disbursed in the form of a check. Students will be notified, via Google Classroom, when the check is ready to be picked up at the Financial Aid Office within 15 days.
